

## RELEASE AND INDEMNIFICATION AGREEMENT

In consideration of observing and/or participating in the shooting sport activities at Washtenaw Sportsman's Club, Incorporated, I agree to sign and enter into this Release and Indemnification Agreement.

I understand that I may observe and/or participate in any or all of the following activities at the club (collectively "Sport Shooting.):

1. Rifle and pistol shooting;
2. Skeet, trap and/or sporting clays;
3. General activities associated with sport firearm shooting; and
4. Archery.

I am entering into this agreement freely, voluntarily, knowingly and specifically state that:

1. I am not dazed, suffering from shock or under the influence of drugs or alcohol.
2. **I understand that this is a full and complete release and indemnification agreement.**
3. There has been no fraud or other conduct used in obtaining my signature and agreement to this document.

### **Participation Obligations**

1. I will comply with all rules and regulations of the Club.
2. If I have questions, I will immediately ask the nearest Club official.
3. If I observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest Club official.
4. I understand that the observation and/or participation in Sport Shooting will expose me to certain risks inherent to Sport Shooting. These risks include, but are not limited to: personal or bodily injury, exposure to increased lead levels, death, and/or property damage. I agree to assume and accept the dangers inherent in the observation of and/or participation in Sport Shooting.
5. I represent that I have no drug, health, or mental problem that could or will interfere with my observation and/or participating in Sport Shooting.
6. I agree that I am responsible for my own safety and the safety of my guest and child that I may bring to the Club.

### **Release & Indemnification**

1. I agree that the Club, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors, or assignees and all participating groups and persons officially connected with the Club (collectively "the Club"), will not be liable if I, my guest or child, suffer any personal or bodily injury, death or property damage as a result of ordinary negligence.

2. I further agree that in the event that the Club becomes liable in any way of or as a result of any actions, negligence or injury caused by me, my guest or child, I agree to indemnify and hold harmless the Club from any and all claims, demands, actual legal costs or other costs or expenses arising out of said actions, negligence or injury, regardless of the party choosing to bring such claim.
